Public awareness letter PUBLIC NOTICE IRON Pennsylvania Land, LLC (IRON) located at 855 Kirby Road, Waynesburg, Pennsylvania 15370, owns and operates a

natural gas pipeline system in your area. Yellow vertical pipeline markers with our name indicate the approximate location and route of our pipelines. IRON maintains and operates a Damage Prevention and Public Awareness Program for its operations of this pipeline system. Keeping the public, the environment, and our pipeline safe with valuable experience, sound judgement and by following federal codes is our top priority. The pipeline is reliable and no underground leaks have been detected. We use preventative measures such as routine patrols and leak surveys to keep the pipeline safe. A copy of this plan is available in our office. This program includes educating and notifying the residents about specific operations requirements and the existence of the program. These requirements include: 1. Contact IRON if you plan to excavate and/or blast on or within two hundred (200) feet of our pipeline right-of-way. Company personnel will locate the pipeline for you to ensure safe excavation and/or blasting. All excavators must use the PA ONE CALL (811) program prior to digging. 2. Contact and/or advise others who you believe to be working near our pipeline to contact IRON before performing any activity that might damage our pipeline system. 3. Be aware of gas leaks and hazards and report them immediately. Signs of gas leaks include the hissing sound of escaping gas, dead vegetation, blowing earth, bubbling water, and the smell of gas. Emergencies include any gas leaks, fire or explosion, natural disasters or civil disobedience. If you suspect that the pipeline is leaking, stay away from the area, have others stay away from the area, and notify the company immediately. In case of fire/explosion or natural disaster near the pipeline, notify the company immediately. If you smell gas inside, get out immediately. If you suspect a leak outside, turn off and abandon any motorized equipment you might be using. Leave the area quickly. Gas is an asphyxiate and can be deadly since it displaces oxygen. By notifying IRON immediately upon any of the above incidents, the appropriate responders will be dispatched promptly and effectively to take care of the emergency. 4. Do not attempt to locate the gas leak with matches or other open flames. Do not remain in a building if there is a strong odor. Do not turn lights on or off or unplug electrical appliance where there is a strong odor. Do not use a telephone in the area of a strong gas odor. Dont use anything that would spark ignition such as cell phones, flashlights, motor vehicles, power tools, electrical equipment, etc. To help us enforce our Damage Prevention and Public Awareness Program and ensure the safe operation of our pipeline system, please call these numbers to report excavation projects or suspected gas leaks

PUBLIC NOTICE Pursuant to the Surface Mining Conservation and Reclamation Act, the Coal Refuse Disposal Control Act, the Bituminous Mine Subsidence and Land Conservation Act, the Pennsylvania Department of Environmental Protection Rules and Regulations and Clean Streams Law notice hereby is given that Consol Pennsylvania Coal Company LLC - Bailey Central Mine Complex CRDA No. 7 and No. 8; 1000 Consol Energy Drive, Suite 100, Canonsburg, PA 15323 has made application to the Pennsylvania Department of Environmental Protection for renewing its existing Coal Refuse Disposal Permit No. 30130701 and the related NPDES Permit PA 0236268. The

current Mining Activity Permit 30130701 was issued on February 17, 2017 and will expire on February 16, 2022. This renewal does not contain revisions to the existing operation. The receiving streams for the permit area is Boothe Run and UNT 32758 of Enlow Fork. The operation is located in Morris Township Greene County and is known as Bailey CRDA #7 and #8. The permit area consists of 1449.0 acres. The facility is located in Morris Township, Greene County; northeast of the existing Bailey Central Mine Complex in the valley located along SR 4014 (Booth School Road), 0.3 miles northeast of its intersection with Valley Church Road. Beginning at a point approximately 1,715 feet northeast of the Booth School Road/Valley Church Road intersection, the proposed permit area extends approximately 7,500 feet to the northeast; then approximately 3,550 feet northwest; then approximately 4,500 feet southwest; then 4,350 feet south to the starting point and in the valley located along Rush Run Road (formerly SR 4009), from its intersection with Valley Church Road (formerly SR 4013). Beginning near the Rush Run Road/Valley Church Road intersection, the proposed permit area extends approximately 10,000 feet to the northeast; with an average width of approximately 4,000 feet. The permit area is located on the Wind Ridge and Rogersville, PA U.S. Geological Survey 7.5 minute topographic map. Dilworth Mine PUBLIC NOTICE Pursuant to the Surface Mining Conservation and Reclamation Act, the Bituminous Mine Subsidence and Land Conservation Act, the Pennsylvania Department of Environmental Protection Rules and Regulations, and the Pennsylvania Clean Streams Law, notice hereby is given that CONSOL Mining Company LLC, 1000 CONSOL Energy Drive, Suite 100, Canonsburg, PA 15317, has submitted an application to the Pennsylvania Department of Environmental Protection to renew its existing coal mining activity permit 30841313 and the related NPDES permit. The current permit was issued on August 13, 1986 and expires on August 13, 2021. This operation, known as the Dilworth Mine, is located in Cumberland Township, Greene County. The permit consists of 11,336 underground permit acres and 59.9 surface acres. The receiving stream is the Monongahela River.
