The Department of Environmental Protection (Department) provides notice of receipt of a renewal application for a Chapter 102, Erosion and Sediment Control Permit for Earth Disturbance Associated with Oil and Gas Exploration, Production, Processing or Treatment Operations or Transmission Facilities. The renewal application is currently under review for Pennsylvania Pipeline Project (Mariner East II). The project proposes to renew approximately 13.66 miles of right-of-way or 164.1 acres of earth disturbance of which 2.7 acres are in Washington County, 37.4 acres are in Westmoreland County, 40 acres are in Indiana County, and 84 acres are in Cambria County. This authorization is required for earth disturbance activities associated with oil and gas exploration, production, processing or treatment operations or transmission facilities when earth disturbance is five acres or greater. Review of this application is being coordinated among the Department and the associated county conservation districts.

PUBLIC NOTIFICATION - BLASTING SCHEDULE R. G. Johnson Co., Inc. plans to conduct blasting at the Bailey Mine, 2 North #1 Airshaft in Richhill Township, Greene County on the property of CONSOL PA Coal Company, LLC, Parcel No. 2211-115 and utilized under their DEP Permit No. 30841316. *The blasting program at the Bailey Mine 2 North #1 Airshaft will be conducted as follows: The Initial Blasts will occur between 8am to 12pm for the first 2 shots. Thereafter blasting shall be conducted 24 hours per day, 7 days per week until the shaft is completed. There will be signs posted to control access to the blasting area. At least one (1) minute but no more than two (2) minutes prior to detonation, a warning signal of three (3) blasts, each lasting approximately five (5) seconds, will sound. An all-clear signal consisting of one (1) long blast,

lasting approximately ten (10) seconds, will sound after each blast indicating the blast area to be safe. The blasting schedule is effective ten (10) days after publication in the local newspaper. Upon request to the PA. Department of Environmental Protection, PO Box 133 New Stanton, PA. 15672 or R. G. Johnson Company, Inc., 25 South College Street, Washington, PA. 15301, any resident or owner of a dwelling or structure that is located within one-half (1/2) mile of any portion of the permitted area where blasting will occur is entitled to receive a pre-blast survey of the dwelling or structure. 12-8

Harvey Mine PUBLIC NOTICE Pursuant to the Pennsylvania Clean Streams Law, the Pennsylvania Department of Environmental Protection Rules and Regulations, the Surface Mining Conservation and Reclamation Act, and the Bituminous Mine Subsidence and Land Conservation Act as amended, notice is hereby given that Consol Pennsylvania Coal Company LLC, 1000 CONSOL Energy Drive, Canonsburg, PA 15317, has submitted an application to the Pennsylvania Department of Environmental Protection to revise Coal Mining Activity Permit No. 30121301 and related NPDES permit for the Harvey Mine. The proposed revision adds approximately 16.2 acres of surface permit area for the installation of the 4B Panel Degas Boreholes. The facilities will be located in Morris Township, Greene County, Pennsylvania and are located on the Rogersville and Waynesburg PA U.S. Geological Survey 7.5 minute topographic maps. The 4B-1a, 4B-1b, and 4B-2 Borehole permit area begins along the eastern side of Hopkins Run Road (T-478), approximately 400 feet south of its intersection with Simpson Chapel Road (T-618). It continues along an existing driveway to the southeast for approximately 0.3 miles where it then splits, with a section continuing to the northeast for approximately 0.2 miles and then to the southwest for 520 feet. The second section continues 0.2 miles southeast from the split, then 0.2 miles east, and 600 feet northwest. The permit varies in width between 50 feet and 300 feet and follows along existing driveways and trails for the majority of the length. The 4B-3 Borehole permit area is located off of the existing EQT Cooper Well pad access road, approximately 0.2 miles south of its intersection with Hopkins Run Road (T-478). It continues to the southwest for 250 feet and then to the southeast for approximately 870 feet, varying in width between 50 and 220 feet. The 4B-4 Borehole permit area is located off of the existing EQT F Iams Well Pad access road, approximately 0.5 miles south/southwest from its intersection with Hopkins Run Road (T-478). It continues south along the access road for 300 feet and extends to the west 200 feet. The proposed permit revision includes construction of five degas boreholes, access roads, soil stockpiles, and erosion and sedimentation control facilities. The application includes a request for variance to encroach within 100 feet of the right-of-way of Hopkins Run Road (T-478), beginning approximately 400 feet south of its intersection with Simpson Chapel Road (T-618) and continuing approximately 430 feet to the south. The variance is required for an access road and erosion and sedimentation control facilities. A stream variance request is proposed for work within 100 feet of a 65 foot section of UNT 40542-R3d to Browns Creek at its headwaters, located approximately 2120 feet west and 700 feet north of the intersection of Ross School Road (T-617) and Hopkins Run Road (T-478). The stream variance is required for an access road for the 4B-3 Borehole facility and installation of erosion and sedimentation control facilities.
