Public Notice of Draft Base General Permit for Short Duration Processing and Beneficial Use of Oil and Gas Liquid Waste (WMGR163)

[52 Pa.B. 419]

[Saturday, January 15, 2022]

The Department of Environmental Protection (Department) is proposing a new base General Permit No. WMGR163 (WMGR163) under the authority of the Solid Waste Management Act (35 P.S. §§ 6018.101—6018.1003) and the Municipal Waste Planning, Recycling and Waste Reduction Act (53 P.S. §§ 4000.101—4000.1904). WMGR163 would authorize the short duration processing, transfer and beneficial use of oil and gas liquid waste to develop or hydraulically fracture an oil or gas well.

The creation of this general permit is a result of legislation (House Bill 336) that became law (Act 70) on July 9, 2021. The language in Act 70 requires the Department, by July 1, 2022, to submit to the Legislative Reference Bureau, for final publication in the *Pennsylvania Bulletin*, a general permit under 25 Pa. Code § 287.643 (relating to registration) for use for the transfer, storage or processing of oil and gas liquid waste at temporary facilities which will be in operation for no more than 180 consecutive days at any one time.

84 Refuse PUBLIC NOTICE Pursuant to the Surface Mining Conservation and Reclamation Act, the Pennsylvania Department of Environmental Protection Rules and Regulations and the Clean Streams Law, notice is hereby given that Eighty-Four Mining Company (contract operator Washington County Land Resources, Inc.), 46226 National Road, St. Clairsville, Ohio 43950 has submitted a Completion Report to the Pennsylvania Department of Environmental Protection, California District Mining Office for a Bond Adjustment to the 84 Refuse Permit # 63743702. The coal refuse disposal area, consisting of a total of 601.0 acres, is located entirely on property owned by Washington County Land Resources, Inc. in Somerset Township, Washington County and is known as the Mine No. 84 Refuse Disposal Area. The permit area is situated as follows: approximately 2000 feet to the south of Ridge Road, approximately 1000 feet to the east of Hixon Road, immediately north of Vanceville Road, and immediately west of Thomas Road. The permit area can be located on the Hackett, PA, U.S. Geological Survey 7 minute series topographical map. The current reclamation bond on account with the PADEP totals \$37,427,491.00. The partial Stage I Release for the Hollow Area is requesting a release of \$3,518,682.00 for grading, installation of synthetic liner and geotextile cap, topsoiling, seeding, and collection channel installation. A total of 53.0 acres of permitted property has been reclaimed. All reclamation activities occurred on property owned by Washington County Land Resources, Inc.
