OPERATING PERMITS

63-00110, Instant Brands LLC, 100 8th Street, Charleroi, PA 15022, Charleroi Borough, Washington County. Application received: May 5, 2022.

In accordance with 25 Pa. Code §§ 127.424, 127.425 and 127.521, the Department is providing notice that it intends to issue a renewal Synthetic Minor Operating Permit for operation of the Charleroi Plant.

Air contamination sources at the facility include a glass melting tank, eight (8) swabbing burners, a truck/rail unloading operation, a mixhouse area, miscellaneous natural gas-fired combustion sources, a mixer/hopper enclosure, miscellaneous fugitive sources, a diesel-fired emergency engine, and a natural gas-fired emergency generator engine.

Potential emissions for the facility have been calculated as follows: 29.06 tons per year of carbon monoxide (CO), 58.13 tons per year of nitrogen oxides (NO_x), 36.06 tons per year of particulate matter less than 10-microns (PM10), 28.03 tons per year of particulate matter less than 2.5-microns (PM2.5), 90.14 tons per year of sulfur oxides (SO2), 10.30 tons per year of volatile organic compounds (VOC), 0.01 ton per year of Hazardous Air Pollutants (HAPs), and 32,832 tons per year of greenhouse gases (CO2e).

The facility is subject to the applicable requirements of 25 Pa. Code Article III, Chapters 121—145. The proposed operating permit includes emission limitations, monitoring, work practice standards, reporting, and recordkeeping requirements for the facility.

The application, DEP's Review Memorandum, and the proposed permit are available for public review during normal business hours at DEP's Southwest Regional Office, 400 Waterfront Drive, Pittsburgh, PA 15222. A file review can be scheduled through the DEP's website at https://www.dep.pa.gov/Citizens/PublicRecords/Pages/Informal-File-Review.aspx.

Any person may submit comments, a request for the Department to hold a public hearing, or a protest to the proposed operating permit or a condition thereof by submitting the information to Nick Waryanka, P.E., Air Quality Engineer, at the Southwest Regional Office. A 30-day comment period from the date of publication of this notice will exist for the submission of comments. Each written comment must contain the name, address and telephone number of the person submitting the comments, identification of the proposed permit (specify Operating Permit 63-00110) and concise statements regarding the relevancy of the information in the proposed permit or objections to issuance of the permit.

A public hearing may be held in accordance with 25 Pa. Code § 127.429, if the Department, in its discretion, decides that such a hearing is warranted based on the information received. If a public hearing is held, all persons who have properly filed a protest under 25 Pa. Code § 127.426 may appear and give testimony. The applicant, the protestant, and other participants will be notified of the decision to hold a hearing (and the time, place and purpose of such hearing) by publication in the newspaper or by the *Pennsylvania Bulletin*, or by telephone, where the Department determines such notification by telephone is sufficient.
