Description of Existing Activity: The application is for a renewal of an NPDES permit for an existing discharge of industrial stormwater.

The receiving stream(s), Unnamed Tributary of Burgetts Fork (WWF), is located in State Water Plan watershed 20-D and is classified for Warm Water Fishes, aquatic life, water supply and recreation. The discharge is not expected to affect public water supplies.

The proposed effluent limits for Outfall 002 are based on a design flow of 0 MGD.—Limits found here.

Code §§ 127.424 and 127.425, the Department of Environmental Protection (DEP) has received an application and is providing notice that it intends to issue a renewed natural minor state-only operating permit to RTS Packaging, LLC for the paperboard partition manufacturing facility located in Charleroi Borough, Washington County. Sources of emissions are grouped as VOC/HAP Sources, which include a spray booth, parts washer, and various adhesives, Fuel Burning Sources totaling

11.2 MMBtu/hr fueled by natural gas, and Fabrication Sources, which include manufacturing lines 1—9 and manual scrap vacuuming controlled by two-cyclone system to control particulate emissions. Potential emissions at this facility are 26.4 tons per year (TPY) PM, 0.7 TPY PM-10, 0.7 TPY PM-2.5, 2.4 TPY VOC, 4.9 TPY NOx, 4.1 TPY CO, 0.03 TPY SOx, and 0.1 TPY total HAP, and 5,804 TPY CO2e. The facility is required to conduct surveys of the site once per day to ensure compliance with visible, fugitive, and malodor emission requirements and maintain records of those surveys. The air quality permit includes operating requirements, monitoring requirements, and recordkeeping requirements for the site. Those who wish to provide the Department with additional written information that they believe should be considered prior to the issuance of the natural minor State-Only Operating Permit may submit the information to Tom Joseph, Facilities Permit Chief, Department of Environmental Protection, Southwest Regional Office, 400 Waterfront Drive. Pittsburgh, PA 15222. Written comments must contain the name, address and telephone number of the person submitting the comments, identification of the proposed Operating Permit (63-00872) and concise statements regarding the relevancy of the information or objections to issuance of the Operating Permit. A public hearing may be held, if the Department, in its discretion, decides that such a hearing is warranted based on the information received. All persons submitting comments or requesting a hearing will be notified of the decision to hold a hearing by publication in the newspaper or by the *Pennsylvania Bulletin*, or by telephone, where the Department determines such notification by telephone is sufficient. Pursuant to the Pennsylvania Clean Streams Law, the Pennsylvania Department of Environmental Protection Rules and Regulations, the Surface Mining Conservation and Reclamation Act, and the

Bituminous Mine Subsidence and Land Conservation Act as amended, notice is hereby given that Consol Pennsylvania Coal Company LLC, 275 Technology Drive, Suite 101, Canonsburg, PA 15317, has submitted an application to the Pennsylvania Department of Environmental Protection to revise Coal Mining Activity Permit No. 30841316 and related NPDES permit for the Bailey Mine.

The proposed revision adds approximately 24.2 acres of surface permit area for the construction of the 6 South 4 Airshaft Facility. The project is located in Aleppo Township, Greene County, Pennsylvania and is located on the New Freeport, PA U.S. Geological Survey 7.5 minute topographic map. The proposed permit area begins along Fairview Road (T-445) approximately 0.7 miles northeast of its intersection with Mudlick Road (T-335). It continues following along the road for approximately 0.4 miles and extends off the eastern edge of the road, varying in width between approximately 300 and 1240 feet. The proposed permit revision includes construction of the airshaft, substation, and boreholes. The proposed permit revision also includes an access road of off Fairview Road, a topsoil stockpile, shaft material stockpile, sediment pond, and other erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of Fairview Road (T445) beginning 0.7 miles northeast of its intersection with Mudlick Road (T-335) and continuing 1965 feet to the northeast. The road variance is required for access to the site, pad construction, haul road installation, shaft cuttings, and erosion and sedimentation control facilities. A stream variance request is proposed for work within 100 feet of 380 feet of UNT 32575 to South Fork Dunkard Fork beginning near its headwaters, located 4215 feet north and 3670 feet east of the intersection of Fairview Road (T-445) and Mudlick Road (T-335) and continuing downstream in a southeasterly direction. The variance is required for pond spillway installation and additional erosion and sedimentation controls.

The proposed permit revision includes two new NPDES discharge points. The first point is at the sediment pond principal spillway outlet into an UNT to South Fork Dunkard Fork - located at 39o49'56.4", 80o27'39.6". The second point is at the sediment trap spillway outlet into an UNT to South Fork Dunkard Fork - located at 39o49'46.6", 80o27'49.9". Treated surface water runoff will be discharged at the new NPDES points.

Blasting may be conducted during site activities. Blasting will not occur until a plan has been approved by the PADEP. When a blasting schedule is finalized, residents, owners of dwellings or other structures, local governments and public utilities located within 1/2 mile of the area where blasting will occur will be notified. All residents, owners of dwellings or other structures located within 1/2 mile of the area where blasting will occur will be informed of their right to a pre-blast survey and how they may request such a survey.

It continues to the southeast approximately 520 feet and then splits. One portion extends 810 feet to the north, varying in width between 125 and 205 feet for the 12L-2 borehole. The other portion continues 425 feet southeast, then 320 feet east, then 890 feet northeast, varying in width between 70 feet and 240 feet for the 12L-1 borehole. The proposed permit revision includes construction of two degas boreholes, access roads, soil stockpiles, and erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of Whipkey Ridge Road (T-465) beginning 0.4 miles southeast of its intersection with Higbee Road (T-447) and continuing 310 feet to the southeast. The road variance is required for site access.
