This project proposes to remediate a highwall adjacent to the Baby Bear Well Pad to a 2:1 slope and reinstall well pad drains at the well pad. The site consists of an access road, well pad and two wet ponds that treat stormwater runoff. Since the construction of the original Baby Bear Well Site a small palustrine emergent wetland (PEM), identified as Wetland 1, has developed on-site. Wetland 1 developed as a result of the construction of the Baby Bear well pad. Seeps from the adjacent highwall and a favorable geographic position at the toe of the highwall slope allow for water to pool at this location. Additionally, well pad drains that facilitate pad drainage have malfunctioned and no longer redirect flow away from the pad area, resulting in the development of Wetland 1. The remediation of the highwall and reestablishment of pad drains will result in the elimination of wetland 1. This permit will result in permanent fill of one (1) PEM wetland for a total of 0.197 acre of direct and permanent wetland impacts. The permanent impacts will be mitigated by the purchase of 0.20 acre of Wetland mitigation bank credits from the Laurel Hill Creek Mitigation Bank.

Bailey Mine PUBLIC NOTICE

Pursuant to the Pennsylvania Clean Streams Law, the Pennsylvania Department of Environmental Protection Rules and Regulations, the Surface Mining Conservation and Reclamation Act, and the Bituminous Mine Subsidence and Land Conservation Act as amended, notice is hereby given that Consol Pennsylvania Coal Company LLC, 275 Technology Drive, Suite 101, Canonsburg, PA 15317, has submitted an application to the Pennsylvania Department of Environmental Protection to revise Coal Mining Activity Permit No. 30841316 and related NPDES permit for the Bailey Mine. The proposed revision adds approximately 24.2 acres of surface permit area for the construction of the

6 South 4 Airshaft Facility. The project is located in Aleppo Township, Greene County, Pennsylvania and is located on the New Freeport, PA U.S. Geological Survey 7.5 minute topographic map. The proposed permit area begins along Fairview Road (T-445) approximately 0.7 miles northeast of its intersection with Mudlick Road (T-335). It continues following along the road for approximately 0.4 miles and extends off the eastern edge of the road, varying in width between approximately 300 and 1240 feet. The proposed permit revision includes construction of the airshaft, substation, and boreholes. The proposed

permit revision also includes an access road of off Fairview Road, a topsoil stockpile, shaft material stockpile, sediment pond, and other erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of Fairview Road (T445) beginning 0.7 miles northeast of its intersection with Mudlick Road (T-335) and continuing 1965 feet to the northeast. The road variance is required for access to the site, pad construction, haul road installation, shaft cuttings, and erosion and sedimentation control facilities. A stream variance request is proposed for work within 100 feet of 380 feet of UNT 32575 to South Fork Dunkard Fork beginning near its headwaters, located 4215 feet north and 3670 feet east of the intersection of Fairview Road (T-445) and Mudlick Road (T-335) and continuing downstream in a southeasterly direction. The variance is required for pond spillway installation and additional erosion and sedimentation controls.

The proposed permit revision includes two new NPDES discharge points. The first point is at the sediment pond principal spillway outlet into an UNT to South Fork Dunkard Fork - located at 39o49'56.4", 80o27'39.6". The second point is at the sediment trap spillway outlet into an UNT to South Fork Dunkard Fork - located at 39o49'46.6", 80o27'49.9". Treated surface water runoff will be discharged at the new NPDES points.

Blasting may be conducted during site activities. Blasting will not occur until a plan has been approved by the PADEP. When a blasting schedule is finalized, residents, owners of dwellings or other structures, local governments and public utilities located within 1/2 mile of the area where blasting will occur will be notified. All residents, owners of dwellings or other structures located within 1/2 mile of the area where blasting will occur will be informed of their right to a pre-blast survey and how they may request such a survey.
