Description of Existing Activity: The application is for a renewal of an NPDES permit for an existing discharge of treated sewage.

The receiving stream(s), Dutch Fork (HQ-WWF), is located in State Water Plan watershed 20-E and is classified for High Quality Waters—Warm Water Fishes, aquatic life, water supply and recreation. The discharge is not expected to affect public water supplies.

Notice is hereby given in accordance with 25 Pa. Code §§ 127.44—127.46 that the Department of Environmental Protection (Department) intends to issue Air Quality Plan Approval 63-01056A to

authorize modification of the existing equipment used in the manufacture and study of natural gas and oil burners for industrial furnaces located in in Fallowfield Township, Washington County.

The facility consists of three (3) natural gas-fired curing ovens, each rated less than 2.0 MMBtu/hr; two (2) natural gas-fired drying ovens each rated at 2.0 MMBtu/hr, two (2) refractory mixing stations; one (1) paint booth, controlled by dry fiberglass filters; welding of fabricated pieces, controlled by a dust collector; one (1) 33.5 hp natural gas-fired emergency generator; testing laboratory, comprised of twenty (20) testing furnaces and one (1) 1.5 MMBtu/hr natural gas-fired boiler; and three (3) parts washers. Potential emissions from the project are 19.95 tons of nitrogen oxides (NO_x), 8.3 tons of carbon monoxide (CO), 3.24 tons of particulate matter less than 10 microns in diameter (PM₁₀), 0.7 ton of sulfur oxides (SO_x), 1.7 tons of volatile organic compounds (VOC), 1.2 tons of combined hazardous air pollutants (HAP), less than 0.5 ton of single HAP, and 21,833 tons of greenhouse gases (GHGs) as carbon dioxide equivalents (CO_{2e}), per year. The Department has determined that the proposed facility satisfies Best Available Technology ("BAT") requirements. The authorization is subject to State regulations including 25 Pa. Code §§ 123.1, 123.2 and 123.31; and Federal National Emission Standards for Hazardous Air Pollutants (NESHAP) from 40 CFR Part 63 Subpart ZZZZ—National Emissions Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines (RICE) and 40 CFR Part 63 Subpart XXXXXX—National Emissions Standards for Hazardous Air Pollutants Area Source Standards for Nine Metal Fabrication and Finishing Source Categories. The Plan Approval has been conditioned to ensure compliance with all applicable rules. This includes emissions restrictions, operational restrictions, work practice, monitoring, recordkeeping, and reporting conditions. Once compliance with the Plan Approval is demonstrated, the applicant will subsequently apply for a State Only Operating Permit in accordance with 25 Pa. Code Subchapter F.

Code §§ 127.424 and 127.425, the Department of Environmental Protection (DEP) has received an application and is providing notice that it intends to issue a renewed natural minor state-only

operating permit to Pleiger Plastics Company for the custom molding polyurethane manufacturing facility located in South Strabane Township, Washington County. Sources of emissions are miscellaneous natural gas sources totaling 16.57 MMBtu/hr, three (3) manual shotblast units, one (1) vapor degreaser, adhesive application, hand casting, machine casting, and six (6) centrifuges and two (2) ovens. Within the 359.1-acre permit boundary, surface activities are proposed to be conducted on 110.1 acres, with underground noncoal mining of 256.6 acres. The receiving streams for this proposed permit area are Tenmile Creek (TSF), and unnamed tributaries to Tenmile Creek.

Consistent with previous surface mining at this site, mining activities are proposed with 100 feet of the following stream sections: 1- Tenmile Creek beginning approximately 2,360 feet upstream from the Pump Station Road Bridge on the east side of the stream and extending upstream approximately 1,660 feet. 2- Unnamed tributary D to Tenmile Creek located approximately 540 feet due west of Morey Road, extending approximately 150' long for placement of fill and a haul road stream crossing. 3- Unnamed tributary E South Branch to Tenmile Creek beginning approximately 700 upstream from its confluence with Unnamed Tributary E and extends upstream approximately 370 feet for the construction and maintenance of a haul road. 4- Unnamed tributary E to Tenmile Creek beginning approximately 1,860 upstream from its confluence with Tenmile Creek and extends upstream approximately 400 feet for placement of fill and a haul road stream crossing. 5- Unnamed tributary E to Tenmile Creek beginning approximately 1,400 feet upstream from the stream's confluence with Tenmile Creek and extends upstream approximately 400 feet for the purpose of relocating and reconstruction of the stream.

The proposed revision adds approximately 9.4 acres of surface permit area for the installation of the 12L-3, 12L-4, & 12L-5 Degas Boreholes. The facilities will be located in Aleppo Township, Greene County, Pennsylvania and are located on the New Freeport, PA U.S. Geological Survey 7.5 minute topographic map. The permit area begins off Blacks Creek Road (T-356) approximately 0.2 miles northwest of its intersection with Higbee Road (T-447). It extends 1250 feet northeast and then splits. One portion extends 1470 feet southeast, varying in width between 80 and 240 feet for the 12L-3 Borehole. The other portion extends 425 feet northwest, varying in width between 250 and 400 feet for the 12L-4 Borehole. The 12L-5 Borehole permit boundary is located along the southwest side of Blacks Creek Road, beginning approximately 310 feet south from its intersection with SR 3018 (Behm Road). It continues along the road for 310 feet to the southeast and varies in width between 50 and 150 feet. The proposed permit revision includes construction of three degas boreholes, access roads, soil stockpiles, and erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of Blacks Creek Road (T-356) at two locations. The first begins 0.2 miles northwest of its intersection with Higbee Road (T-447) and continues 210 feet to the northwest, and the second begins 310 feet south of its intersection with SR 3018 (Behm Road) and continues 310 feet to the southeast. The road variances are required for site access and erosion and sedimentation controls for the 12L-3 and 12L-4 borehole facilities and access, the borehole pad, borehole installation, and erosion and sedimentation controls for the 12L-5 borehole.

Stream variance requests are proposed for work within 100 feet of two streams: Blacks Creek (32568) beginning 370 feet south and 175 feet west of the intersection of Blacks Creek Road (T-356) and SR 3018 (Behm Road) and continuing upstream 360 feet southeast; and a 70-foot section of variance for UNT 32568I to Blacks Creek at its culvert under Blacks Creek Road (T-356) located approximately 0.2 miles northwest of the intersection with Higbee Road (T-447) and continuing upstream in a northeasterly direction. The stream variances are required for site access, borehole pad construction, and erosion and sediment control facility installation.
