63-00565, Washington Penn Plastics Co., 480 Johnson Road, Washington, PA 15301, South Strabane Township, Washington County. Application received: July 31, 2023. In accordance with 25 Pa. Code §§ 127.424 and 127.425 the Department of Environmental Protection (DEP) gives notice that they intend to issue a State Only Operating Permit (SOOP) renewal to Washington Penn Plastics/Arden Division to authorize the production of custom polyolefin compounds. The facility is located in South Strabane, Washington County. The operation process at this facility include ten extrusion lines, blenders, mixers, silos, an emergency generator, and several dust collectors to control emissions. The facility has the potential to emit 47.91 tpy PM10 and less than 1 ton per year of NOx, VOC, CO, and SOx. The proposed SOOP contains emission restriction, testing, monitoring, recordkeeping, reporting and work practice standards derived from the applicable requirements of 25 Pa. Code Article III, Chapters 121—145, 40 CFR Part 63, Subpart ZZZZ—National Emission Standards for Hazardous Air Pollutants for Stationary Reciprocating Internal Combustion Engines. A person may oppose the proposed State Only Operating Permit by filing a written protest with the Department through Noor Nahar via mail to Pennsylvania Department of Environmental Protection, 400 Waterfront Drive, Pittsburgh, PA 15222. The Department issued a renewal natural minor State Only Operating Permit for operation of the Accutrex Products, Inc. Cecil Plant in Cecil Township, Washington County. Emission sources at this facility include a spray paint booth, two powder coating booths, two drying ovens, a Super Koropon Primer spray booth, a Shim Stock surface coating line, a sandblasting unit with a baghouse that exhausts indoors, and an emergency generator. The facility currently has permit conditions restricting potential emissions to 45.0 tons per year (tpy) of VOC, 9.0 tpy of a single HAP, and 22.0 tpy of total HAPs. The proposed revision adds approximately 9.4 acres of surface permit area for the installation of the 12L-3, 12L-4, & 12L-5 Degas Boreholes. The facilities will be located in Aleppo Township, Greene County, Pennsylvania and are located on the New Freeport, PA U.S. Geological Survey 7.5 minute topographic map. The permit area begins off Blacks Creek Road (T-356) approximately 0.2 miles northwest of its intersection with Higbee Road (T-447). It extends 1250 feet northeast and then splits. One portion extends 1470 feet southeast, varying in width between 80 and 240 feet for the 12L-3 Borehole. The other portion extends 425 feet northwest, varying in width between 250 and 400 feet for the 12L-4 Borehole. The 12L-5 Borehole permit boundary is located along the southwest side of Blacks Creek Road, beginning approximately 310 feet south from its intersection with SR 3018 (Behm Road). It continues along the road for 310 feet to the southeast and varies in width between 50 and 150 feet. The proposed permit revision includes construction of three degas boreholes, access roads, soil stockpiles, and erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of Blacks Creek Road (T-356) at two locations. The first begins 0.2 miles northwest of its intersection with Higbee Road (T-447) and continues 210 feet to the northwest, and the second begins 310 feet south of its intersection with SR 3018 (Behm Road) and continues 310 feet to the southeast. The road variances are required for site access and erosion and sedimentation controls for the 12L-3 and 12L-4 borehole facilities and access, the borehole pad, borehole installation, and erosion and sedimentation controls for the 12L-5 borehole.

Stream variance requests are proposed for work within 100 feet of two streams: Blacks Creek (32568) beginning 370 feet south and 175 feet west of the intersection of Blacks Creek Road (T-356) and SR 3018 (Behm Road) and continuing upstream 360 feet southeast; and a 70-foot section of variance for UNT 32568I to Blacks Creek at its culvert under Blacks Creek Road (T-356) located approximately 0.2 miles northwest of the intersection with Higbee Road (T-447) and continuing upstream in a northeasterly direction. The stream variances are required for site access, borehole pad construction, and erosion and sediment control facility installation.
