On November 16, 2022, Markwest Liberty Midstream & Resources submitted a request for a de minimis emission increase at its Lowry Compressor Station. This Notice is published per 25 Pa. Code § 127.449(i). The compressor station is a natural gas gathering station with natural gas-fueled compressor engines. The project is the completion of a manufacturer offered "CAT Low Emission Engine Upgrade" on Source ID # 105 (CAT3516 LE, 1,340-bhp, SI, NG-fueled, compressor engine) and the associated removal of two (2) natural gas-driven pneumatic devices. The upgrade will reduce NO_x emissions at full engine capacity to a maximum of 0.5 grams per bhp-hour. Markwest Liberty will comply with requirements in DEM-63-00947.

- ENVIRONMENTAL QUALITY BOARD Acceptance of Rulemaking Petition for Study On March 12, 2024, the Environmental Quality Board accepted a rulemaking petition for study under 25 Pa. Code Chapter 23 (relating to Environmental Quality Board policy for processing petitions—statement of policy). The petition, submitted by Consol Pennsylvania Coal Company, requests the amendment of 25 Pa. Code § 93.9v (relating to Drainage List V) **to redesignate Fletcher Run in Greene County from High Quality—Warm Water Fishes to Warm Water Fishes**. Under 25 Pa. Code § 93.4d(a) (relating to processing of petitions, evaluations and assessments to change a designated use), the Department of Environmental Protection (Department) is required to publish a notice of intent to assess candidate waters. The Department’s assessment notice for this rulemaking petition will appear in a future issue of the Pennsylvania Bulletin.
