# DETERMINATION OF APPLICABILITY FOR RESIDUAL WASTE GENERAL PERMITS

• WMGR123SW073, EQT Production Company, 400 Woodcliff Drive, Canonsburg, PA 15317, Union Township, Washington County. A Determination of Applicability for coverage under Residual Waste General Permit No. WMGR123 was received. EQT Production Company is proposing to install an aboveground storage tank at the Caton Well Pad, located at 165 Pleasantview Road, Finleyville, PA 15332, that will be used as a water reuse storage/transfer facility to be used to support unconventional well completions at adjacent well pads. The tank will be a circular-based (114.58 ft. x 24.5 ft. operating height) carbon steel open-air storage tank, nominal 22,000 bbl (924,000 gallons) capacity, within a double-wall 110% secondary containment system. The storage facility will also include a drive-on truck containment system and transfer pumps. Application received: July 29, 2024. Deemed administratively complete: August 13, 2024.

The applicant is proposing to:

- 1. Construct and maintain a temporary piped stream crossing on Sugar Run (WWF), consisting of three (3) 23-LF long, 36" (diameter) Corrugated Galvanized Steel Pipes, and other erosion and sedimentation control devices, having a combined temporary watercourse impact of 307 LF to Sugar Run, and a temporary floodway impact of 0.16 acre to the floodway of Sugar Run, as well as a temporary watercourse impact of 10 LF to an unnamed tributary (UNT) to Sugar Run (WWF), namely UNT-2, and a temporary floodway impact of 0.01 acre to the floodway of UNT-2.
- 2. Remove the existing 57.5-LF long, 17-LF wide, Reinforced Concrete Steel I-Beam Bridge, which carries SR 2003 over Sugar Run, and to construct and maintain a replacement 222-LF long, 18' x 6' Pre-Cast Box Culvert, including scour protection, resulting in a net loss of approximately 165 LF of open channel, and having a permanent watercourse impact of 270 LF to Sugar Run and a permanent floodway impact of 0.08 acre.
- 3. Construct and maintain a new 18" RCP stormwater outfall, namely EW2-3, within the floodway of Sugar Run, including end walls and a rock apron, and having a permanent floodway impact of 0.01 acre.
- 4. Construct and maintain a new 18" RCP outfall at the outlet of an existing culvert which carries a UNT to Sugar Run, namely UNT-3, including end walls and a rock apron, and having a permanent watercourse impact of 68 LF and a temporary watercourse impact of 41 LF to UNT-3, as well as a permanent floodway impact of 0.01 acre and a temporary floodway impact of 0.08 acre.
- 5. Remove an existing 44-LF long, 15" CMP carrying another UNT to Sugar Run, namely UNT-4, and to construct and maintain a replacement 87-LF long, 18" RCP culvert and outfall, including end walls and rock apron, resulting in a net loss of 43 LF of open channel, and having a permanent watercourse impact of 87 LF to UNT-4, and a permanent floodway impact of 0.03 acre.
- 6. Remove an existing 31-LF long, 15" CMP carrying another UNT to Sugar Run, namely UNT-6, and to construct and maintain a replacement 49-LF long, 24" RCP culvert and outfall, including end walls and rock apron, resulting in a net loss of 18 LF of open channel, and having a permanent watercourse impact of 49 LF and a temporary watercourse impact of 13 LF to UNT-6, as well as a permanent floodway impact of 0.01 acre and a temporary floodway impact of 0.03 acre.
- 7. Remove an existing 63-LF long, 18" RCP carrying another UNT to Sugar Run, namely UNT-7, and to construct and maintain 73 LF of 18" RCP, which will relocate this watercourse into proposed Stormwater Basin # 1, resulting in a loss of 10 LF of open channel, and having a permanent floodway impact of 0.01 acre.

- 8. Remove an existing 52-LF long, 18" TPP carrying another UNT to Sugar Run, namely UNT-8, and to construct and maintain 61-LF of 18" RCP, which will relocate this watercourse into proposed Stormwater Basin # 1, and resulting in a net loss of 9 LF of open channel.
- 9. Place and maintain fill within 0.03 acre of the floodway of another UNT to Sugar Run, namely UNT-9, also having a temporary watercourse impact of 46 LF to UNT-9, and a temporary floodway impact of 0.09 acre.
- 10. Mitigation for stream impacts will be provided by constructing approximately 1,000 LF of perennial stream channel restoration within a UNT to Pumpkin Run (WWF), located in Cumberland Township, Green County. This work will include the placement of fill along the embankment of the UNT to Pumpkin Run, and the installation of mud sills, cross vanes, and toe logs, as well as appurtenant grading and planting.

Pursuant to the Surface Mining Conservation and Reclamation Act of 1977, (SMCRA) the Coal Refuse Disposal Control Act, as amended, Bituminous Subsidence and Land Conservation Act, the Pennsylvania Department of Environmental (DEP) Protection Rules and Regulations, and Pennsylvania Clean Streams Law, notice is hereby given that Champion Processing, Inc. (CPI), doing business at 563 Route 18, Burgettstown, Pennsylvania 15021, has submitted an application for the revision and renewal of the Champion Refuse Disposal Area Mining Permit No. 63733701 and related National Pollutant Discharge Elimination System (NPDES) Permit No. PA0023400.

The site is located approximately 15 miles west of Pittsburgh, Pennsylvania, southwest of the intersection of U.S. Route 22 and State Route (SR) 980. The permit boundary begins approximately 1,200 feet southwest of the intersection of SR 22 and SR 980 (40.426925, 80.294667) and continues in a southern direction for approximately 5,000 feet, generally following the alignment of SR 980. Next, the permit boundary turns in a western direction at a location approximately 3,000 feet north of the intersection of SR 980 and Beech Hollow Road (40.404043, -80.290604) and continues approximately 4,500 feet in a western direction. Next, the permit boundary turns in a northern direction at a location approximately 1,000 feet north of the intersection of I-576 and Candor Road (40.408673, -80.308398) and approximately 4,100 feet northwest of the cul-de-sac termination of Beech Hollow Road (40.403592, -80.296887). Next, the permit boundary continues for approximately 2,000 feet in a northwestern direction, generally following the alignment of Candor Road but offset approximately 500 feet to the east of Candor Road. Next, the permit boundary turns west at a location approximately 3,100 feet south of the intersection of SR 22 and Candor Road (40.424580, -80.312791) and continues along the eastern edge of Candor Road for approximately 1,500 feet. Next, the permit boundary turns to the east at a

location approximately 1,700 feet southwest of the intersection of SR 22 and Candor Road (40.424580, -80.312791). Finally, the permit boundary will continue in a northeastern direction for approximately 5,000 feet where it connects with the point located approximately 1,200 feet southwest of the intersection of SR 22 and SR 980. The Clinton, PA U.S. Geological Survey 7.5-minute topographic map contains the area described.

CPI proposes to renew the subject Mining Permit, remove 407.6 acres from its currently permitted land area of approximately 600 acres, and revise the reclamation plan. The deleted acreage is proposed to be designated as Title IV land under the SMCRA and will be reclaimed through the Abandoned Mine Land (AML) program regulated by DEP s Bureau of Abandoned Mine Reclamation.

The remaining 192.4 acres subject to the renewed Mine Permit will be reclaimed to support future industrial development. The permit operations will generally consist of cleaning out and enlarging existing storm water management ponds, as necessary to support onsite reclamation and future use, re-grading the existing on-site coal refuse, and capping the refuse with an impermeable cover material and topsoil such that the reclaimed area is stable and has the ability to sustain future use.

During construction, the proposed operation will discharge treated mine drainage water into Tributary 33824 to Little Raccoon Run, with a designated use of Warm Water Fishes, via existing approved Outfall 001 (40.405256, -80.30005) under the existing NPDES Permit No. PA0023400. Treatment will continue until raw water quality meets the effluent criteria in the NPDES Permit. Upon final site reclamation, the treatment system will be decommissioned, and the site will discharge through eight (8) additional NPDES outfalls:

Proposed Outfall 002: Discharge from Pond 1 to Tributary 33827 of Little Raccoon Run approximately 2,400 feet north of the intersection of Candor Road and Hilltop Drive (40.412001, -80.307561).

Proposed Outfall 003: Discharge from Pond 2 to Tributary 33824 of Little Racoon Run approximately 3,500 feet northwest of the intersection of SR 980 and Beech Hollow Road (40.411128, -80.299683).

Proposed Outfall 004: Discharge from Pond 3 to Tributary 33829 of Little Racoon Run approximately 2,400 feet north-northeast of intersection of SR 980 and Beech Hollow Road (40.411078, -80.290989).

Proposed Outfall 005: Discharge from Pond 4 to Tributary 33829 of Little Racoon Run approximately 3,500 feet south of intersection of SR 980 and US Route 22 (40.416800, 80.291872).

Proposed Outfall 006: Discharge from Pond 5 to an Unnamed Tributary of Tributary 33824 of Little Racoon Run approximately 3,400 feet northwest of intersection of SR 980 and Beech Hollow Road (40.408653, -80.295428).
