Description of Existing Activity: The application is for a renewal of an NPDES permit for existing discharges of treated industrial waste, storm water runoff, and groundwater.

The receiving streams, Taylors Run (WWF) and Pigeon Creek (WWF), are located in State Water Plan watershed 19-C and is classified for Warm Water Fishes, aquatic life, water supply and recreation. The discharges are not expected to affect public water supplies.

The proposed effluent limits for Internal Monitoring Point 101 are based on a design flow of 0.0219 MGD.—Limits.
