Code §§ 127.424 and 127.425 the Department of Environmental Protection (DEP) gives notice that they intend to issue a State Only Operating Permit (SOOP) renewal to All Clad to authorize the continued operation of their clad metal sheet stock and cookware manufacturing plant located in Cecil Township, Washington County.

The facility consists of furnaces, presses, punches, lathe machines, polish and grind units, an emergency generator, and some small dip tank. It has several baghouses to control emissions of particulate matter (PM). This facility has the potential to emit 6.71 tons per year of PM₁₀, 2.13 tons per year of NO_x, 0.009 ton per year of SO_x, 1.03 tons per year of CO, and 0.22 ton per year of VOCs. The proposed SOOP contains emission restriction, testing, monitoring, recordkeeping, reporting and work practice standards derived from the applicable requirements of 25 Pa. Code Article III, Chapters 121—145 and 40 CFR Part 60 Subpart JJJJ.

A person may oppose the proposed State Only Operating Permit by filing a written protest with the Department through Noor Nahar via mail to Pennsylvania Department of Environmental Protection, 400 Waterfront Drive, Pittsburgh, PA 15222. Each protest or set of written comments must contain the name, address and telephone number of the person submitting the comments, identification of the proposed State Only Operating Permit (63-00886) and a concise statement of the objections to the Operating Permit issuance and the relevant facts upon which the objections are based.

The proposed permit revision includes construction of a degas borehole, access road, soil stockpile, and erosion and sedimentation control facilities.

The application includes a request for variance to encroach within 100 feet of the right-of-way of SR 3018 (Behm Road) beginning 0.2 miles west of its intersection with Blacks Creek Road (T-356) and continues 305 feet to the west. The road variance is required for site access, borehole pad construction, the topsoil stockpile, and erosion and sedimentation controls.
