On December 13, 2024, Range Resources Corporation (3000 Town Center Boulevard, Canonsburg, PA 15317), submitted a notice of a de minimis increase which would result in an emission increase at its Orenchuk Russell 11890 Well Pad (Jefferson Township, Washington County). This Notice is published per 25 Pa. Code § 127.449(i). The Orenchuk Russell 11890 Well Pad is an unconventional natural gas well pad. This facility is regulated by General Permit GP-5A-Unconvenional Natural Gas Well Site Operations and Remote Pigging Stations (2700-PM-BAQ0268), AG5A-63-00026A/GP5A-63-01043A, authorized for use on November 20, 2020. The project is the installation of a 10.1-horsepower, emergency backup generator. The well pad will comply with requirements in DEM-63-01043A. Installation of this emergency backup generator will not change potential air emissions from any other source at the facility.

Per Section A Condition 15 of BAQ-GPA/GP-5A Unconventional Natural Gas Well Site Operations and Remote Pigging Stations which requires compliance with the emission limits in 25 Pa. Code § 127.449(d) among other requirements, the Department has determined this change is exempt from Plan Approval as a de minimis emission increase.

Notice is hereby given that Dana Mining Company of Pennsylvania, LLC, 966 Crafts Run Road, Maidsville, WV 26541, has requested bond adjustment for the 4-West Mine Permit No. 30031301 pursuant to the Surface Mining Conservation and Reclamation Act. The 4-West Mine permit was issued on April 25, 2005, and is located in Dunkard Township, Greene County. The permit area is situated north of Dunkard Creek, south of Whiteley Creek, east of Shannon Run and Fox Run and west of Davistown. The mine consists of 16,152.8 acres of underground permitted area and 140.1 acres of permitted surface area. The proposed area can be found on the Garards Fort, PA and Osage PA U.S.G.S., 7 minute series topographic maps.

A bond adjustment of \$1,275,575 is requested for the following: 24.3 acres of surface site located at the former Marshall Portal Site now owned by Garrett Mining Services, LLP.; 23.5 acres of surface site located at the former Main Portal Site now owned by 7 Equities, LLC.; 2.6 acres of surface site located at the former Eisenhower Shaft Site obtained by PA DEP. Also included in the bond adjustment is the sealing of boreholes, shafts, slopes, and the demolition of structures. Total bond held for the 4-West Mine is \$1,570,076.

The requested release adjustment is for the reclamation cost of the sites that are no longer required due to the purchase of two sites, the Department's issued Post Mining Land Use Change from forestland and unmanaged natural habitat to industrial/commercial at the former Marshall Portal and Main Portal, the PA DEP obtaining the Eisenhower site, the demolition of structures and the sealing of boreholes, shafts, and slopes. The bond liability to remain is \$294,501.

The proposed permit revision is for changing the length of the West Greene District Long Wall Panels LW-76 through LW-79 located within the approved Cumberland Mine underground permit area and underground subsidence control plan area. The proposed revision area is located in Center and Jackson Townships, Greene County, south-southwest of Waynesburg, Pennsylvania and can be found on the Holbrook, Pennsylvania 7.5-minute U.S. Geological Survey topographic map.

The approved West Greene District for long wall mining encompasses approximately 2,855 acres and is rectangular in shape. The northern border begins at a point approximately 1 mile northwest of the intersection of Hoges Run Road and Golden Oaks Road (SR-18). The northern border continues in a southeastern direction for approximately 3.13 miles. The eastern border begins at a point approximately 0.74 mile east of the intersection of Center Highlands Road (T434) and Hargus Creek Road (SR-3011). The border then turns to the southwest and continues for approximately 1.46 miles. The southern border begins at a point approximately 0.66 mile west-northwest of the intersection of Turkey Hollow Road and Iron Rock Road (T457). The southern border then turns to the northwest and continues for approximately 3.13 miles. The western border begins at a point approximately 0.26 mile southwest of the intersection of Macedonia Road and Bristoria Road (SR-3020). The western border continues northeast approximately 1.44 miles back to the place of origin. Subsidence modeling has been conducted to estimate the location and extent of stream pooling that may be caused due to potential grade changes associated with long wall mining for Garner Run, Hoge Run, House Run, McCourtney Run and Hargus Creek overlying Panels LW-76 through LW-79 of the Cumberland Mine West Greene District. Nine (9) stream segments were identified as potentially exhibiting pooling at or greater than one (1) foot and therefore may require post-mining stream restoration activities. Eight (8) restoration areas have been identified to eliminate the nine (9) proposed pooling areas should they occur at the time of undermining. The location of the proposed stream restoration areas is as follows:

Potential restoration area GAR RA1 is located east of Golden Oaks Road (SR-18), on Garner Run (40643). The proposed restoration area begins approximately 776 feet

south of the intersection of Golden Oaks Road (SR-18) and Bristoria Road (SR-3020) and continues southwest approximately 720 feet along Golden Oaks Road (SR-18). Potential restoration area MCR RA1 is located east of Golden Oaks Road (SR-18), on McCourtney Run (40628). The proposed restoration area begins approximately 1,265 feet north of the intersection of Golden Oaks Road (SR-18) and Bristoria Road (SR-3020) and continues southwest approximately 908 feet along Golden Oaks Road (SR-18).

Potential restoration area MCR RA2 is located south of Golden Oaks Road (SR-18), on McCourtney Run (40628). The proposed restoration area begins approximately 970 feet north of the intersection of Golden Oaks Road (SR-18) and Tower Road (T436) and continues west approximately 2,120 feet along Golden Oaks Road (SR-18).

Potential restoration area MCR RA3 is located south of Golden Oaks Road (SR-18), on McCourtney Run (40628). The proposed restoration area begins adjacently to the intersection of Golden Oaks Road (SR-18) and Norman Hollow Road (T444) and continues southwest approximately 2,750 feet along Golden Oaks Road (SR-18).
