Pursuant to the Pennsylvania Clean Stream Law, the Pennsylvania Department of Environmental Protection rules and regulations, the Surface Mining Conservation and Reclamation Act, and the Coal Refuse Disposal Control Act as amended, notice is hereby given that Consol Pennsylvania Coal Company LLC, 275 Technology Drive, Canonsburg, PA 15317, has submitted an application to the Pennsylvania Department of Environmental

Protection to revise the Bailey Coal Refuse Disposal Areas (CRDA) No. 7 and No. 8 Facility Coal Refuse Disposal Area Permit (No. 30130701) and related NPDES permit.

The proposed revision adds approximately 1.9 acres for the installation of the CRDA No. 8 Outfall Collection System Project. The facility will be located in Morris Township, Greene County; and on the Wind Ridge, PA U.S Geological Survey 7.5-minute topographic map. The permit area begins at the existing Enlow Fork Mine C2 Borehole Facility off of Valley Church Road (T-605). It extends to the northeast approximately 1000 feet and varies in width between 55 and 105 feet. The proposed permit revision includes installation of a 2,050 foot long pipeline, a new injection borehole, and erosion and sedimentation controls.

Stream variances are requested for the following four streams: Boothe Run (32755), beginning approximately 975 feet upstream of the culvert under Valley Church Road (T-605) and continuing upstream 1470 feet in a northeasterly direction; a 60-foot section of variance for UNT 32755A to Boothe Run, beginning 1115 feet north and 1020 feet east of the intersection of Valley Church Road and old Booth School Road and continuing upstream in a northerly direction; work within 100 feet of the entire 112-foot section of UNT 32755B to Boothe Run, located 1245 feet north and 1210 feet east of the intersection of Valley Church Road and old Booth School Road; and work within 100 feet of the entire 102 foot length of UNT 32755A-1 to Boothe Run, located 1200 feet north and 975 feet east of the intersection of Valley Church Road and old Booth School Road. The stream variances are requested for the pipeline installation, temporary access, and erosion and sedimentation controls.

Site activities are proposed within 125 feet of abandoned well 668 on parcel 1801-111A, located at the following coordinates: Latitude: 39.97773 and Longitude: -80.3797. The well owner is unknown. The pipeline will be installed within 125 feet of the well, however the well will not be impacted due to the installation.
