Conditional State Water Quality Certification under Section 401 of the Clean Water Act for the United States Army Corps of Engineers Pennsylvania State Programmatic General Permit-7 (PASPGP-7)

- On December 10, 2024, the United States Army Corps of Engineers Baltimore, Philadelphia and Pittsburgh Districts (Corps) under section 404(e) of the Federal Clean Water Act (CWA) (33 U.S.C. § 1344(e)) issued jointly by Special Public Notice 24-36 the proposed (PASPGP-7) for a 30-day public comment period which closed on January 24, 2025. On April 18, 2025, the Corps' Baltimore District requested State Water Quality Certification (SWQC) on behalf of the Baltimore, Philadelphia and Pittsburgh Districts under section 401 of the CWA (33 U.S.C. § 1341) from the Department of Environmental Protection (Department) for discharges of dredged and fill material into waters of the United States, including jurisdictional wetlands, within this Commonwealth that would be authorized under PASPGP-7. Section 401(a) of the CWA (33 U.S.C. § 1341(a)) requires an applicant seeking coverage under PASPGP-7 to provide the Corps with certification from the Commonwealth that its discharge will comply with the applicable provisions of sections 301—303, 306 and 307 of the CWA (33 U.S.C. §§ 1311—1313, 1316 and 1317). The Department has established water quality standards for this Commonwealth and programs to achieve those standards consistent with the applicable provisions of the CWA, which have been approved by the United States Environmental Protection Agency (EPA). The Department is providing notice of its conditional SWQC for use

by applicants seeking coverage under PASPGP-7 for projects that do not require any Federal license or permit other than a section 404 permit under the CWA. PASPGP-7 continues the Corps' recognition of the Commonwealth's permitting process for activities affecting watercourses, bodies of water and wetlands authorized under the Dam Safety and Encroachments Act (32 P.S. §§ 693.1—693.27) and its implementing regulations under 25 Pa. Code Chapter 105 (relating to dam safety and waterway management). PASPGP-7 allows applicants to obtain both Corps section 404 permits and coverage under State permits or other authorizations for water obstructions and encroachments submitted to the Department and for projects requiring permits or authorizations in this Commonwealth. Through the incorporation of Federal and State permitting standards in one process, PASPGP-7 continues a streamlined process for permit applicants without compromising comprehensive environmental protection. This conditional SWQC applies to activities that qualify for PASPGP-7 within the jurisdiction of section 404 of the CWA (33 U.S.C. § 1344) and structures or work in or affecting navigable waters of the United States under section 10 of the Federal Rivers and Harbors Act of 1899 (33 U.S.C. § 403). The Department published a notice at 55 Pa.B. 6477 (September 6, 2025) to accept comments on the proposed SWQC for the PASPGP-7 during a 30-day public comment period that concluded on October 6, 2025. No comments were received. Consistent with section 401 of the CWA, the Department certifies that activities authorized by the Corps under the PASPGP-7 will comply with the applicable provisions of sections 301—303, 306 and 307 of the CWA (33 U.S.C. §§ 1311—1313, 1316 and 1317). The Department further certifies that the construction, operation and maintenance of the projects in accordance with PASPGP-7 will comply with the Commonwealth's water quality standards provided the project applicant complies with the following SWQC conditions and constructs, operates and maintains the project in compliance with the terms and conditions of State law permits obtained to meet these SWQC conditions:

- 1. Prior to beginning any activity authorized by the Corps under PASPGP-7, the applicant shall obtain from the Department all necessary environmental permits or approvals, and submit to the Department environmental assessments and other information necessary to obtain the permits and approvals, as required under State law, 284 NOTICES PENNSYLVANIA BULLETIN, VOL. 56, NO. 2, JANUARY 10, 2026 including The Clean Streams Law (35 P.S. §§ 691.1—691.1001), the Dam Safety and Encroachments Act (32 P.S. §§ 693.1—693.27), the Surface Mining Conservation and Reclamation Act (52 P.S. §§ 1396.1—1396.19b), the Noncoal Surface Mining Conservation and Reclamation Act (52 P.S. §§ 3301—3326), The Bituminous Mine Subsidence and Land Conservation Act (52 P.S. §§ 1406.1—1406.21), the Coal Refuse Disposal Control Act (52 P.S. §§ 30.51—30.66), the Solid Waste Management Act (35 P.S. §§ 6018.101—6018.1003), the Hazardous Sites Cleanup Act (35 P.S. §§ 6020.101—6020.1305), the Land Recycling and Environmental Remediation

Standards Act (35 P.S. §§ 6026.101—6026.908), 58 Pa.C.S. §§ 3201—3274 (relating to development), the Air Pollution Control Act (35 P.S. §§ 4001—4015) and the regulations promulgated thereunder, including 25 Pa. Code Chapters 77, 78, 78a, 86—91, 92a, 93, 95, 96, 102, 105, 127 and 260a—299.

- 2. Environmental assessments required under these regulations, in addition to other regulatory requirements, must be complied with as a condition of the SWQC for PASPGP-7 consistent with section 401 of the CWA.
- 3. Fill material may not contain any waste as defined in section 103 of the Solid Waste Management Act (35 P.S. § 6018.103).
- 4. Applicants and projects eligible for the PASPGP-7 must obtain all State permits or approvals, or both, necessary to ensure that the project meets the State's applicable water quality standards, including a project-specific SWQC.

- The Department has determined that these SWQC conditions are necessary to achieve the Commonwealth's water quality standards, which have been approved by the EPA as compliant with the CWA. The SWQC conditions achieve these standards through compliance with existing environmental programs administered by the Department under State laws and regulations. This SWQC would be subject to the Department's determination that the final PASPGP-7 activities are consistent with the Federal Coastal Zone Management Act (16 U.S.C. §§ 1451—1468). This SWQC would only be available for projects that do not require any Federal authorization other than authorization from the Corps under section 404 of the CWA or section 10 of the Federal Rivers and Harbors Act of 1899. Applicants seeking authorization for activities not eligible for coverage under PASPGP-7, or for activities that require another Federal authorization (such as an interstate natural gas pipeline, a gas storage field, a nuclear or hydroelectric project requiring authorization by another Federal agency), must submit a request to the Department for a project-specific SWQC. Persons aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) under section 4 of the Environmental Hearing Board Act (35 P.S. § 7514) and 2 Pa.C.S. §§ 501—508 and 701—704 (relating to Administrative Agency Law). The Board's address is Environmental Hearing Board, Rachel Carson State Office Building, Second Floor, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457. Appeals must be filed with the Board within 30 days of receipt of notice of this action unless the appropriate statute provides a different time. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law. Pursuant to the Pennsylvania Clean Streams Law, the Pennsylvania Department of Environmental Protection Rules and Regulations, the Surface Mining Conservation and Reclamation Act, and the Bituminous Mine Subsidence and Land Conservation Act as amended, notice is hereby given that Marshall County Coal Resources, Inc., 46226 National Road, St. Clairsville, OH 43950, is making application to the Pennsylvania Department of Environmental Protection for an amendment to the Marshall County Mine Coal Mining Activity Permit No. 30161301 and related NPDES permit.

The revision proposes 5.49 acres for the construction of the 6N6E-1A and 6N7E-1 degasification borehole sites, access road, and erosion and sediment control structures.
